Stories that inspired us this week

UK borders and migration policy

On the Rwanda policy:

- <u>There will be no removals to Rwanda at least until late autumn after the</u> <u>European Court of Human Rights rejected the government's appeal</u> to unblock the injunction that prevented removals taking place in June. <u>The injunction</u> <u>remains in place until the outcome of the case due at the High Court starting on</u> <u>5 September</u> that will look at the lawfulness of the policy.
- <u>Concerns over the scheme's lawfulness continue to be raised by the Joint</u> <u>Committee on Human Rights</u>.

• Meanwhile, <u>Liz Truss has indicated she would seek to expand on the UK-Rwanda</u> <u>partnership</u> by facilitating partnerships with more countries to act as offshoring locations, should she be elected as Prime Minister.

Specific migrant groups

Lord Harrington, <u>the Minister for Refugees called on councils to do more to help</u> <u>accommodate Afghan refugees</u>. Over 10,000 resettled <u>Afghans are currently</u> <u>accommodation in hotels whilst awaiting social housing, including in Yorkshire and</u> <u>Humber</u>, while more are expected to be resettled to the UK in coming months. <u>Some</u> <u>Afghan families have been separated due to a shortage of hotel spaces</u>, following the cancellation of hotel contracts and the inability to find long-term accommodation for them. Charities and <u>local groups organising matches between hosts and Ukrainian guests</u> warn they face a shortage of hosts, despite many people registering with the official Homes for Ukraine scheme. (Source: Politics Home)

On modern slavery, two groups have been highlighted recently as particularly vulnerable:

- <u>People in the asylum system are at risk of modern slavery</u>, according to a report from the United Nations High Commissioner for Refugees (UNHCR) and the British Red Cross; they recommend some ways in which to reduce that risk.
- <u>Research conducted by peer researchers highlights the vulnerability of migrant</u> <u>live-in care workers to modern slavery</u>.

International news

The European Commission has allocated €171 million for EU projects in order to support reception, asylum, and return systems in Cyprus, Spain, Greece, Italy and Poland. In Italy, <u>a new shelter for migrants opened on the Sicilian island of Pantelleria</u> which will be coordinating the transfer of migrants from Tunisia to other parts of Italy. Outside of Europe, the US state of <u>Texas controversially has begun sending buses of</u> <u>asylum seekers from Central America to Washington DC and New York City</u>. The Republican Texan governor is seeking to make a political point about border towns' capacity to shelter migrants. (Source: Reuters)

Leicester has been running events to celebrate the 50th anniversary of the arrival of Ugandan Asian refugees to their city: <u>three plays have told the stories of local</u> <u>families who arrived in Leicester</u> alongside <u>an ongoing exhibition at Leicester</u> <u>Museum and Art Gallery following the stories of those fleeing Uganda</u> and exploring their impact on the culture and history of the city. For those still coming down from the victory at the Women's Euros 2022, check out this story on <u>Changing Lives FC</u>, an <u>Essex football team comprised entirely of</u> <u>refugees and migrants</u>.
